**IT IS HEREBY ORDERED THAT:**

- 1 The court order of 14 February 2018 is hereby varied by the insertion of a further order extending the rule nisi granted on 7 November 2017 to 7 March 2018.
- 2 The first respondent is directed to deliver an affidavit on or before 16 March 2018 explaining its late compliance with paragraph 1 of the court order of 19 January 2018 and to show cause why sanctions should not be applied.
- 3 The applicant may answer thereto, if it so chooses, on or before 23 March 2018.
- 4 Any replying papers thereto may be delivered on or before 28 March 2018.
- 5 The case is postponed to 4 April 2018 at 08:30 for a Sanctions hearing.

6 The Rule Nisi is also extended to that date.

7 The legal representatives of the 4th respondent are excused from attending all those court proceedings which they elect not to attend.
