The 2019 Summit, which took place from 07 to 09 October, was held under the theme "Accelerating Digital Transformation."

November 2019 at the Cape
Town International Convention
Centre. Regarded as the largest technology exhibition in Africa, the event brought together approximately 15,000 attendees,
450 speakers and 500 exhibitors.

AfricaCom launched a brand-new zoned event called AfricaTech. In this zone, innovators and architects at the forefront of Africa's journey towards the Fourth Industrial Revolution met to share knowledge of enterprise transformation and the digital future. The zoned exhibition area was dedicated to the IoT, AI, blockchain, fintech, cloud technology and cybersecurity. It enabled an innovative space to showcase the latest technologies and trends while offering a host of networking opportunities.

CRAN was exposed to the latest innovations and technology trends. This exposure will enable CRAN, through consumer advocacy campaigns, to empower consumers of ICT services in Namibia to make the best use of ICT products and services while remaining protected and within the law.

The Communications Regulators' Association of Southern Africa (CRASA) renewed its commitments to CRAN. CRASA is an important stakeholder as ICT Policy and Regulation always has international ripple effects.



FINANCE AND AUDIT COMMITTEE

CRASA held its first Finance and Audit Committee meeting in Gaborone, Botswana, from 14 to 16 August 2019. The main aim of the meeting was to give an update on the implementation of action items of the 8th Annual General Meeting and operational plan for 2019/2020. In addition, the meeting also considered the Management Accounts for the quarter ended 30 June 2019, the updated CRASA Risk Register and the CRASA Internal Audit Plan for 2019/2020.

ELECTRO MAGNETIC FIELDS WOR-KSHOP AND 1ST CRASA CONSU-MER COMMITTEE

CRAN attended CRASA's Electro Magnetic Fields (EMF) and Accessibility to Mobile Communications Workshop and the 1st Consumer Committee meeting which were held from 09 to 13 September 2019 in Victoria Falls, Zimbabwe. The events were hosted by the Postal and Telecommunications Regulatory Authority of Zimbabwe (POTRAZ).

The EMF and Accessibility to Mobile Communication workshop aimed to broaden the understanding of the concepts of EMF and its impact on consumers health. Updates where provided on international exposure recommendations and standards by the International Commission on Non-lonizing Radiation Protection (ICNIRP). The

workshop debated issues relating to the implementation of successful accessibility features, services, business practices, policies and regulatory programmes in SADC. Delegates also received information on interrogating the impact of counterfeit electronic communications products on economies and consumer protection.

The inaugural Consumer Committee meeting zeroed in on policies and regulatory initiatives for consumers with special needs. The Committee presented a position paper for the Southern African Development Community (SADC) guidelines in this regard. An assessment report has also been developed on ICT accessibility policies and initiatives within SADC.

The Committee commenced with the development of a position paper on the Impact of Counterfeit Products on Consumer Protection and Economy and the development of Consumer Protection guidelines on EMF. Furthermore,

guidelines on the development of a position paper on Internet of Things (IoT) and the impact of Consumer protection guidelines was achieved during the meeting.

The workshop was attended by CRASA member countries, namely; Namibia, Zimbabwe, Botswana, Zambia, Tanzania, and the Democratic Republic of Congo (DRC). The Committee elected the DRC as the new Chairperson of the CRASA Consumer Committee (for the next three years) and the Vice Chair is Tanzania.



SADC ICT MINISTERS APPROVE FRAMEWORKS

(SADC) Ministers meeting

Keeping in the SADC area, CRAN attended the SADC Ministers meeting for ICT, Public Information, Transport and Meteorology from 19 to 20 September 2019 which was held in Dar es Salaam, United Republic of Tanzania. Delegates deliberated on several issues of importance to the region in relation to infrastructure in support of regional integration.

The meeting was attended by representatives from the SADC partners and implementing agencies from the four sectors. It was preceded by a meeting of Senior Officials from the ICT, Public Information, Transport and Meteorology sectors and a SADC High Level Ministerial Round Table Dialogue on Innovative and Emerging High Capacity Broadband Access Technologies.

Namibia was represented by the Minister of ICT (MICT), Honourable Stanley Simataa; Minister of Works and Transport (MOWT), Honourable John Mutorwa; as well as the Executive Director of MICT, Mr. Mbeuta Ua-Ndjarakana and the Executive Director of MOWT, Mr. Willem Goeiemann. CRAN was represented by Jochen Traut, Chief Operations Officer and Ronel Le Grange, Head: Electronic Communications.

The Ministers in the ICT and Information sectors approved the Multi-Stakeholder Intraregional and Trade Facilitation Project. This project is aimed at promoting and facilitating the participation of Small, Medium and Micro Enterprises (SMMEs) in the regional e-commerce ecosystem. Member States were urged to provide access to their national public television channel online

and through a mobile app to enhance information dissemination. They were also urged to consider ratifying the African Union Convention on Cyber Security and Personal Data Protection which has set out obligations for businesses and organisations that collect, process and store individuals' data.

The Ministers approved several frameworks and guidelines for implementation which included;

- The SADC Mobile Broadband Gap Analysis Guidelines;
- Framework for Setting up the SADC Regional Computer Incident Response Team (CIRT);
- Framework for SADC Shared Satellite Programme;
- Competition Assessment Framework for Communications Sector in SADC;
- SADC Universal Postal Service and Access Regulatory Guidelines;
- SADC Postal E-commerce and Trade Facilitation Guidelines:
- · SADC Regional E-commerce Hub Framework; and
- Action Plan 2019 on SADC Women and Youth Empowerment in ICT.

The general scope of the agenda of WRCs is established four to six years in advance, with the final agenda set by the ITU Council two years before the conference, with the concurrence of a majority of Member States. These Conferences are held after every three (3) to four (4) years.

It is the purpose of WRC to review and revise, if necessary, the Radio Regulations, the international treaty governing the use of the radio-frequency spectrum and the geostationary-satellite and non-geostationary-satellite orbits. Revisions are made on the basis of an agenda determined by the ITU Council, which takes into account recommendations made by previous WRCs.

Under the terms of the ITU Constitution, a WRC can:

- Revise the Radio Regulations and any associated frequency assignment and allotment plans:
- Address any radiocommunication matter of worldwide character;
- Instruct the Radio Regulations Board and the Radiocommunication Bureau, and review their activities; and
- Determine questions for study by the Radiocommunication Assembly and its Study Groups in preparation for future Radiocommunication Conferences.



TYPE APPROVAL AMENDMENTS

Back in Namibia, CRAN published
General Notice No. 361, dated 11
September 2019, in Government Gazette
No. 6992. This notice is a statement to
amend the Regulations in Respect of
Type Approval and Technical Standards
for Telecommunications Equipment,
Communications Act (No. 8 of 2009).

In terms of the Regulations, 'telecommunications equipment' is defined as "communications or networking equipment with an interface to public network or wide area network services and includes, but not limited to, telecommunications terminal equipment, information technology equipment (including but not limited to a digital set-top box decoder), radio communication equipment powered by means of an internal or external electrical AC/DC energy source and electronic communications network equipment."

The aim of the statement is to provide a person or entity that intends to connect any equipment to an electronic communication network in Namibia for the purpose of electronic communications, or use, sell or offer for sale or re-sale telecommunications equipment in Namibia that is not type approved or exempted from type approval, to apply on the prescribed form and submit the telecommunications equipment specifications to the Authority.


Thus, equipment which are not telecommunications equipment as per the definition and that do not require type approval, including those listed in Schedule 1 of the Gazette, are as follows;

Application for a type approval certificate will still be required for equipment already type approved, however, this will be done through a simplified type approval process. Equipment imported for research and development purposes will

not require a type approval certificate, however authorisation to import such equipment should still be granted by the Authority. Additionally, type approval of equipment will be equipment specific and not per person.

Namibia, like other countries, has seen an increase in the use of technology and accessibility to internet services for all. Children have not been left behind in this respect. However, Internet and mobile technologies pose potential risk, especially to children, if they are not managed correctly.

This is a very important topic for CRAN as it speaks to advocating for and protecting our most vulnerable consumers while also equipping them with the knowledge and tools to excel in the future that awaits them economically and socially.

The Ministry of Gender Equality and Child Welfare, in partnership with United Nations International Children's Emergency Fund (UNICEF) and other partners, hosted another National Conference on Child Online Protection in Windhoek from 18 to 19 September 2019. The Conference theme was "Continuing the fight against online child abuse and exploitation".

This event brought together experts from government ministries, civil society, industry partners, academia, the United Nations (UN) stakeholders and children, to discuss the significant progress the country has made in respect of the Framework for Action established in 2016. The Framework for Action was updated to represent the current situation and potential dangers.

The internet and social media platforms are changing the scope, opportunity and forms of violence, abuse and exploitation of children. Emilia Nghikembua, Head: Legal Advice, attended the Conference and presented on the topic "The role of CRAN in combatting Online Child Sexual Exploitation and Abuse". As the regulator of the ICT sector, CRAN is informing and educating consumers through awareness campaigns and engaging with consumers at every touch point. However, Mrs. Nghikembua also emphasised the need for reforms in the law. She proposed reforms to the Communications Act (No. 8 of 2009), the Electronic Transaction Bill, as well as the Cybersecurity Bill.


