Thank you for accepting our invitation to this important public consultative meeting on the application for reconsideration submitted by Paratus Telecommunications (Pty) Ltd, in relation to the award of a Class Comprehensive Telecommunications Service Licence to the Municipal Council of the City of Windhoek (CoW).

On 03 June 2020, CRAN published the application for reconsideration submitted by Paratus Telecommunications (Pty) Ltd in the *Government Gazette* for public comments. In the gazette notice, CRAN invited all interested parties to submit written representations on the application by Paratus and to make such submissions within fourteen (14) days from the date of publication in the government gazette. We received six (6) written representations in this regard from Telecom Namibia Limited, the Internet Society of Namibia, ICT Trading Enterprises CC, Dimension Data, Hon. Henk Mudge and Mr. H Barnard.

CRAN further deemed it necessary to host the public hearing, in terms of Regulation 14 of the Regulations regarding Licensing Procedures, which makes provision for CRAN to host a public consultative meeting to provide stakeholders with an opportunity to make oral submissions and/or amplify their written submissions. We therefore expect this public hearing to provide additional information or clarify on certain issues raised by stakeholders in their respective submissions.

CRAN prides itself as a dynamic regulator and will continue to independently regulate the ICT industry by creating a competitive and levelled playing field in order to increase access to telecommunications, and advanced information services to all regions of Namibia in order to promote just, reasonable and affordable prices.

In terms of the process for today, as set out in today's programme, we will allow presenters to make their oral presentations for 30 minutes, subsequent to which the stakeholders will ask questions of clarity.
